### SIR JOHN FORREST ARCHIVE

Sir John Forrest was born on August 22, 1847 at Preston Point, near Bunbury, Western Australia and died at sea on September 3, 1918. As an explorer and surveyor, he led pioneer expeditions into Australia's western interior and as a statesman became Western Australia's first Premier from 1890 to 1901. During this period he sponsored public works construction and negotiated the state's entry into the Australian Commonwealth in 1901.

After entering Western Australia's survey department in 1865, Forrest, in 1869, led a search expedition for the missing explorer Ludwig Leichhardt and, in 1870, an expedition from Perth along the Great Australian Bight to Adelaide. In 1874 he completed a 2,700 mile (4,300 kilometre) crossing of the continent from Champion Bay to the telegraph line between Adelaide and Port Darwin. Forrest served as Western Australia's Surveyor General from 1883 to 1890, when he became Premier. Serving also as colonial treasurer, he sponsored harbour works and railroad development and introduced a plan for supplying water to the goldfields. He also worked for woman suffrage and for expanding land settlement. In the negotiations for Australian federation between 1887 and 1901, he championed the interests of smaller states, winning railroad and tariff benefits for Western Australia. He was knighted in 1891.

Elected to the first federal Parliament in 1901, he served as Minister of Defence (1901–03), as Treasurer in several Liberal ministries between 1905 and 1914, and in the coalition wartime ministry of William Morris Hughes (1917–18). In 1918 he became the first person born in Australia to enter the British peerage, wherapon he was called Baron Forrest of Bunbury. As he died without male issue, the title lapsed. He wrote *Explorations in Australia* (1875) and *Notes on Western Australia* (1884).

### THE PAPERS

The John Forrest collection of personal papers has been donated to the Society by Nicholas Hasluck from the estate of his father, the late Sir Paul Hasluck. Sir John Forrest's death on 3 September 1918 was followed in 1920 by the sale of The Bungalow, home of John and Margaret Forrest (née Hamersley). Forrest was a thorough keeper of his own records and left a large quantity of private papers to complement the official government records that cover his state and federal political careers. Unfortunately, after his death these private records were scattered. Local historian, journalist on the West Australian and a founder of the WA Historical Society, Paul Hasluck was working on a biography of Sir John Forrest in the 1930s when he acquired for that purpose, various papers and research materials. Transferred to Canberra in 1940 as part of the war effort, Hasluck was unable to proceed further with the project. Two completed chapters were presented to the Society many years later and published in the silver jubilee edition of *Early Days*, vol. 8 part 1, 1977. This collection was saved from possible destruction by Paul Hasluck and remained in his family's possession until 2018 when the Society became the fortunate beneficiary.

These are quintessentially private papers, made up of a great variety of personal archival items. The collection contains records from Sir John Forrest's time as surveyor and explorer in the 1860s-1880s, as Premier in the 1890s, as a founding member of the federal parliament, and eventually as a federal cabinet minister. Items relate to his public life (albums, press cuttings, speech notes, invitations, travel plans) and his personal life in its final years when he lived chiefly in Melbourne. The papers also reflect Forrest's family life, including the intermarried and intermeshed Forrest, Hamersley and North families. The Forrests had no children but were close to the children of Margaret's sister Flora, who had married Forrest's

friend and colleague, Frederic Dudley North, Secretary to the Premier and Clerk of the Executive Council. For most of the time after her husband's death until her own demise in June 1929, Margaret lived with or near Flora. The collection contains substantial material relating to Frederic and Flora's family including personal and business correspondence and financial and property records. Various items point to another aspect of the family story – records relating to Alexander Forrest's estate, property ownership papers, mining and other investments (all evidence of a web of family financial arrangements), personal and household invoices, photographs, letters, and a range of Hamersley documents. This collection enriches our understanding of Forrest's life and times as a significant figure in colonial, state and national history.
